DKMM wishes to accept quotes for its electronics recycling program. The program consists of one day collection events as well as recycling the electronics collected from residents on an ongoing basis at set points in Delaware, Knox, Marion, and Morrow counties.

One Day Collections:

The contractor is required to use their own labor and equipment to service the one-day events to unload participant vehicles and properly handle electronics in a safe and professional manner. Contractor should provide enough staff to ensure participant wait time is kept to a minimum. DKMM will work with the contractor to establish the dates, hours and locations of the collection events that are available to DKMM residents (no businesses).

Ongoing DKMM Staffed Collections:

We currently have one location setup in Mount Gilead and hope to have a location in Delaware set up during this contract period. DKMM will staff these locations and the contractor will be contacted to schedule a pickup of materials once a full load (as determined by contractor) has been collected. Contractor shall provide pallets and gaylord containers to be filled as well as the staff to load the material onto the box truck at the time of the scheduled pickups.

This Agreement will begin as soon as an Agreement is executed by both parties and will end December 31, 2024, if not renewed, extended, or adjusted as mutually agreed by both parties in accordance with the Agreement.

Typical materials collected at past events include but are not limited to the following. It is expected that these items will be included in the collection bid as well as other typical residential electronics.

Computer Monitors DVD and VCR Recorder/Players

Hard Drives Cameras

Laptops Gaming Devices
Monitors Microwaves
Other computer peripherals Coffee Pots
Televisions (including consoles) Cell Phones
Radios Cords

Cords Printers

Materials **not** to be collected include:

Items containing Freon
Items containing Mercury (light bulbs, thermostats)
Hazardous waste

INSURANCE

Selected contractor shall secure and maintain throughout the duration of the contract insurance with liability limits of \$1,000,000 for injury due to death of one person and a total of no less than \$1,000,000 to protect itself and the interests of the District against all hazards or risks.

Selected contractor shall have Workers' Compensation insurance on all employees working the District locations as required by the laws of the State of Ohio. Items to be included with your quote.

PAYMENT

Once the scope of work has been completed to both party's satisfaction, the selected contractor will invoice DKMM. The invoice shall include the total amount of material recycled and proof of data destruction. Payment will be made within 30 days by DKMM.
